In exercise of powers conferred by Section 179 of Companies Act – 2013 and Article 67 of the Articles of Association of DHBVNL and all other enabling powers in this behalf, the Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL) is pleased to make partial modification in Regulation 1.2.1 of the Recruitment & Promotion Policy of Non-Gazetted Technical Staff (as applicable to DHBVNL for the post of Assistant Lineman) as amended from time to time with the latest amendment vide DHBVNL Notification No. 36/SE/Admn/RECT-05 dated 25.08.2017 to the extent as under:-

1.2 Assistant Linemen:-

1.2.1 97% posts of Assistant Lineman (ALM) will be filled up by direct recruitment from amongst the persons who passes the following qualification:-

(i)(a) Matric with 02 years ITI course in Electrician/Wireman trade duly recognized by National Council for Vocational Education and Training (NCVET)/State Council for Technical Education & Vocational Training (SCTEVT) with a minimum 60% (no rounding-off) marks in respect of General Category/other Category Candidates and 55% (no rounding-off) marks of SC category candidates of Haryana domicile only;

or

(b) Lineman & Electrician (Maintenance & Repair) from VEI (Vocational Educational Institute) with a minimum 60% (no rounding-off) marks in respect of General Category/other Category Candidates and 55% (no rounding-off) marks of SC category candidates of Haryana domicile only;

- (c) Full-Time 2 years National Skills Qualification Framework (NSQF) level-4 in Electrician/Wireman/Electrician Power Distribution trade in engineering duly recognized by NCVET/ SCTEVT with a minimum 60% (no rounding-off) marks in respect of General Category/other Category Candidates and 55% (no rounding-off) marks of SC category candidates of Haryana domicile only;

or

- (d) Two years of Senior Secondary Vocational Course in Electrical Technology conducted by CBSE with minimum 60% (no rounding off) marks in respect of General Category/ other Category Candidates and 55% (no rounding off) marks of SC category candidates of Haryana domicile only;

with a minimum 55% (no rounding-off) marks in respect of General Category/other Category Candidates and 50% (no rounding-off) marks of SC category candidates of Haryana domicile subject to the candidate acquired the qualification **in the same line as prescribed in the minimum qualification** in terms of State Government, Haryana instructions dated 16.06.1979 reiterated vide instruction dated 25.03.2016, as amended from time to time;

with a minimum 50% (no rounding-off) marks in respect of General Category/ other Category Candidates and 45% (no rounding-off) marks of SC category candidates of Haryana domicile subject to the candidate acquired the qualification **in the same line as prescribed in the minimum qualification** in terms of State Government, Haryana instructions dated 16.06.1979 reiterated vide instruction dated 25.03.2016, as amended from time to time.

Note:-

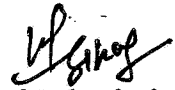
The candidates who have acquired the qualification in various disciplines other than mentioned above shall not be considered.

- (b) Must have passed Hindi/Sanskrit upto Matric standard.
- (c) Computer Eligibility Test would be conducted.

Provided that these posts may be filled-up through outsourcing purely on contractual basis, against sanctioned vacant posts, through contractor/ service provider, by calling NIT through open bidding; without sending requisitions to the Employment Exchange or advertisement in the Newspapers, for a period not exceeding one year at a time or till the regular selected candidates are appointed, whichever is earlier.

This Notification supersedes all the previous orders/ instructions issued by the erstwhile Haryana State Electricity Board/ Dakshin Haryana Bijli Vitran Nigam Limited from time to time in respect of above paras only and will be applicable with immediate effect.

This issues with the approval of the Additional Chief Secretary to Government of Haryana, Energy Department-cum-Chairman, HPUs subject to ex-post-facto approval of the Board of Directors of DHBVNL.

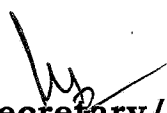
